Regarding No Objection Certificate for affiliation to be issued to Darshan Academy Kot Sadeeq, Kala Singha Road, Jalandhar- 144002 by CBSE New Delhi.

Sir,

In connection with above said referred matter.

As per the documents produced by the management of your school along with affidavit and recommendation of district Education Officer (Sr. Secondary) Jalandhar and Director Education Department (Sr. Secondary) Punjab Chandigarh and after due verification of said recommendations, the no objection certification has been issued by the Punjab Govt. on the following terms and conditions:-

1. That in future if any time any complaint / inspection and after coming to know any fact comes to the knowledge that you have given the application on the basis of wrong information and facts and also it is found that you have not complied with the instructions of Punjab Govt. Which has been issued by him from time to time and also it found that you have not fully complied with terms and conditions given by you in the affidavit that in those circumstances the said no objection certificate can be withdrawn at any time.
2. That it will be mandatory in your school to teach Punjabi language upto 10th class and CBSE will make the arrangement for taking examination of the Punjabi necessary that in case of non-compliance by you the said no objection certificate can be withdrawn at any time.



After obtaining no objection certificate of affiliation from CBSE New Delhi the management of the school shall pay salaries and all other allowances to the teaching staff and non-teaching staff on the same pattern as per Govt. employee and school management shall be bound to pay the same. In case of non-compliance by you the no objection certificate shall be withdrawn at any time immediately.

4. That you yourself and your management shall also assure and bound to give information to District Education or any other senior officer of Education Department who wants any information from you time to time and you shall be bound to co-operate to give information in this regard to them.

This sanction is granted as per the order of Hon'ble Education Minister dated 30-06-2009 issued by him.
